# THE SURVEY == JANUARY 1970

With the trapping licence now in hand, and while waiting for the traps to arrive -- traps have been promised by the National Parks and Wildlife Service, per Mel Williams -- the preliminary groundwork has been proceeding.

The air photograph enlargements have arrived; George Croghan has produced an enlarged map of the area; Lin Paish is preparing lists of plants likely to occur in the area to be used as plotting sheets for the flora-habitat survey; the first trapping transect has been selected and a strip map showing detailed habitats of this transect will be prepared.

A recent visit to the Australian Museum provided some very helpful information regarding trapping techniques, baits, handling of animals, etc. The Curator and staff are interested in our project, and have promised further help with identification

No reports of unusual sightings have been received during the last couple of months, with the exception of a Sandpiper seen beside a large puddle of rainwater near Faulconbridge Postoffice, on 25th. January. Normally seen on the gravel and sand-beds beside creeks and rivers, this bird must have considered the ridge-top wet enough - not surprisingly, considering the recent wet weather.

The Paishs have been kept busy feeding an injured mother Satin bower-bird and two fledglings. The meeting opened at 8.10 PM. Tree Preservation Order. MMMs Bowden outlined the policy of her Society, which is in favour of a blanket Order. Mr. Overton "Since other Councils have blanket orders, why cannot the Blue Mountains Council ?" Mr. Kelly "There are policing difficulties, as there are with rubbish dumping. People are reluctant to inform on their neighbours. Because of this I think the Order ought not to be a blanket one but should refer to specific species and/or areas." Mr.King "Subdividers clear before referring their plans to Council and specific orders in these circumstances would be as difficult to police as blanket orders. Mrs. Overton "Preservation orders on specific trees would tend to generate citizens pride in their trees. Mr. Overton "Do other Councils have policing problems?" Chairman "They are generally lenient but occasionally the Order is applied strictly. The policy appears to be 'live and let live' " Mrs.Stanborough "In Adelaide Tree Preservation Orders are very strictly policed." Mr.Kelly "Some Councils require that any felled tree must be replaced by a seedling tree." Mr. Hyndes "Why dont we recommend a blanket order on nominated species and sizes; for example, no trees of girth over 18 inches or height over 12 feet may be removed." Mr.Perrin "With an order like this, all trees will eventually die out, so that a programme of education will be necessary." Miss Douglas "Cannot we have a blanket order together with an order for specific areas and/or species?" Mr.Kelly "I agree with an order along the lines of Mr. Hyndes Miss Bowden "It is essential that enough seedlings be preserved to replace the natural depletion of mature trees."

As the agreed alloted time for this item had expired, a motion to extend the discussion for a further 15 minutes was put and carried.

Mrs Stanborough "I suggest that the Societies discuss the ideas presented tonight and report back to the Federation." hearting baw Mr King "Will it be difficult to amend a Tree Preservation Order?" Mr Kelly "No. It is merely necessary for a Council to pass a resolution amending the Order, then to place a notice in the Gazette". Moved Mrs. Stanborough, seconded Mr. Martin:

"that the Federation recommend the the Council to place a blanket cover of all trees of every class in the T.P.O." Carried, Mr. Perrin dissenting.

Moved Mr. Hyndes, seconded Miss Bowden: "that every Society consider the advisability of a blanket ban and a ban on the removal of certain species in specified areas and recommend to the Federation which species and areas should be 'preserved' "

#### Myall Lakes

Mr King explained the background to the Sim Committee. He said that the Government is procrastinating in the dedication of coastal National Parks until beach mining is complete, so that it could not be said that the Government condoned mining in National Parks. Miss Douglas "There were eight people on the Sim Committee, six of whom were conservationists, and two represented mining interests. In order that the Report could be unanimous the six gave ground to the two miners. It was felt that the best results would be gained by recommending "scientific areas". No agreement could be got on Myall Lakes but Mr. Strom feels that if the Report could be debated in Parliament, mining on Myall Lakes could be stopped."

Moved Mr. King, seconded Mrs. Stanborough:

"that the Federation write to Messrs. Dunbier and Coates asking their help to have the Sim Report debated in Parlt."

(Note. The Report was debated before letters could be sent, so the Hon. Members were asked to help in having Cabinet bring down legislation to implement the recommendations of the Sim Report.)

#### Mining under National Parks

Mr King "Dr.McMichaels seems apathetic about the fate of the Royal National Park. I would like us tto oppose bad planning of the works and associated landscaping.

Chairman "Since we cannot prevent the construction of these vent--ilator shafts in National Parks we should attempt to see that the shaft works and landscaping be designed or approved by the N.P.&W.S. so that they fit into the landscape." Mr Perrin "We should oppose all shafts on all Parks."

Moved by Mr. Perrin, seconded by Mr. Kelly: "that the Federation write to the N.P.&W.S. to ask whether whether alternative means of ventilation have been investigated."

### Airstrip in Burrendong Arboretum

Mrs Overton "Mr. George Althofer has for the last twentyfive years been planting specimens of every Australian tree in an arboretum near Burrendong Dam. There are now plans to build an airstrip in the arboretum. The BMGSGAP has written to the local M.Ps., local (Wellington) newspaper and the Park Trust. The reply from the Trustees stated that 'your opinions have been noted.'"

Chairman "Who is building the airstrip?"

Mr King "A trust is in charge of the Park. It is being developed as a tourist resort and they want a landing ground as near the

#### Glenbrook Lagoon

Mr King "In this connection I rang the N.P.&W.S. and was told that since the Lagoon is within one mile of a school it is already a faunal sanctuary, which means that shooting and trapping are forbidden, and since it cannot be doubly protected, it cannot be made a Wildlife Refuge. It was suggested that I write to the N.P.&W.S. setting out reasons for protecting the habitat. They will then investigate and perhaps give us information which we can submit to the Council for the management of the area."

Moved by Mr King, seconded by Mr. Hyndes:
"that Federation write to the N.P.& W.S. asking for an in-vestigation of Glenbrook Lagoon."

# Extensions to the Blue Mountains National Park
